## CLUB PURE TERMS AND CONDITIONS

1. Monthly payments are debited automatically on the first day of each month. By signing the attached form, you agree to pay the stipulated monthly payment until further written notice.
2. If you would like to cancel your club membership, please provide one month's notice in writing to the address overleaf.
3. Club PURE payments are non-refundable.
4. Club PURE is designed for the named individual on the membership application form. All benefits and discounts will only be applied when the member is visiting the salon.
5. Members are permitted to use their Club PURE balances to pay for treatments taken by other people, but they will not receive the discounts or other club benefits.
6. The Club PURE discount cannot be used against parties, treatment packages, gift vouchers (sold or redeemed), or on top of other discounts or special offers (members will receive either the club discount or an offer discount whichever is better for the member). Members can use their Club PURE account balance to pay for any treatments used with another discount or special offer.
7. Club members will be contacted either via email or phone if email is not available to give notice of PURE events and offers. Members who wish to attend events will be required to pay any applicable booking fees at time of booking.
8. Members can carry forward balances to a maximum of four times their normal monthly payment. PURE will contact members who reach this limit, and members are required to use the balance within a month of notification to avoid their club account becoming suspended.
9. Any accounts that are suspended will be cleared after 6 months of non-activity.
10. PURE reserves the right to alter these terms and conditions or withdraw the scheme at any time – members will be notified of any changes.
11. PURE reserves the right to refuse membership or to cancel membership where a member is not abiding by the terms and conditions of the club.
12. Membership to Club PURE is salon specific. Account balances cannot be used at other salons.
13. If a member has treatments costing more than the amount in the member's account, the difference is payable at the time of treatment.
14. When joining, members are required to show photographic ID with address details and the card that the member intends to be debited each month. This can be a passport, utility bill or drivers licence in the member's name.
